Re: Letter of Permission (LOP), 2018 Critz Tybee Run Fest, Activities within the State's Shore Protection Act Jurisdiction, South Beach Parking Lot, Tybee Island, Chatham County, Georgia

Dear Ms. Dover:

This letter is in response to your request to host the 2018 Critz Tybee Run Fest in the South Beach parking lot on Tybee Island. This event combines multiple courses for participants over a two-day period. The temporary project within the State's Shore Protection Act (SPA) Jurisdiction will commence no sooner than 15 days after the date on this letter and be completed no later than Saturday, February 3, 2018.

Your request includes the placement of one (1) 20ft. X 20ft. tent, and one (1) 105ft. X 50ft. tent that will provide cover for vendor services, tables, chairs, generators, a stage with an associated public address system and other Critz Run Fest amenities. Additionally, one (1) dumpster and two (2) portable toilet facilities to service the event will be placed on the existing paved parking area located at 16th and Strand. The event will set up Friday, February 2, 2018 and removed Saturday, February 3, 2018. All power cables will be identified and secured appropriately. All zip ties associated with the installation of the festival zone must be placed in appropriate trash receptacles and removed from the public area during breakdown.

The Department authorizes the temporary event facilities as depicted in the attached project description and location map. Best Management Practices (BMPs) should be used to prevent any additional impacts at the site and to protect the shore jurisdictional areas. This Letter of Permission is not meant to exempt the above referenced activity from future environmental laws.

No impacts to the sand sharing system are proposed and access to the beach is available to the public at existing crossovers along the strand. **No unauthorized equipment, materials or debris may be placed, disposed of, or stored in jurisdictional areas.** Any incidental impacts associated with this project must be rectified by fully restoring areas to their pre-construction topographic and vegetative states.

This LOP is valid for the above referenced project. Any change in the use, location, dimensions, or configuration of the approved project, without prior notification and approval from this office could result on the revocation of this permission and in the required removal of the materials and



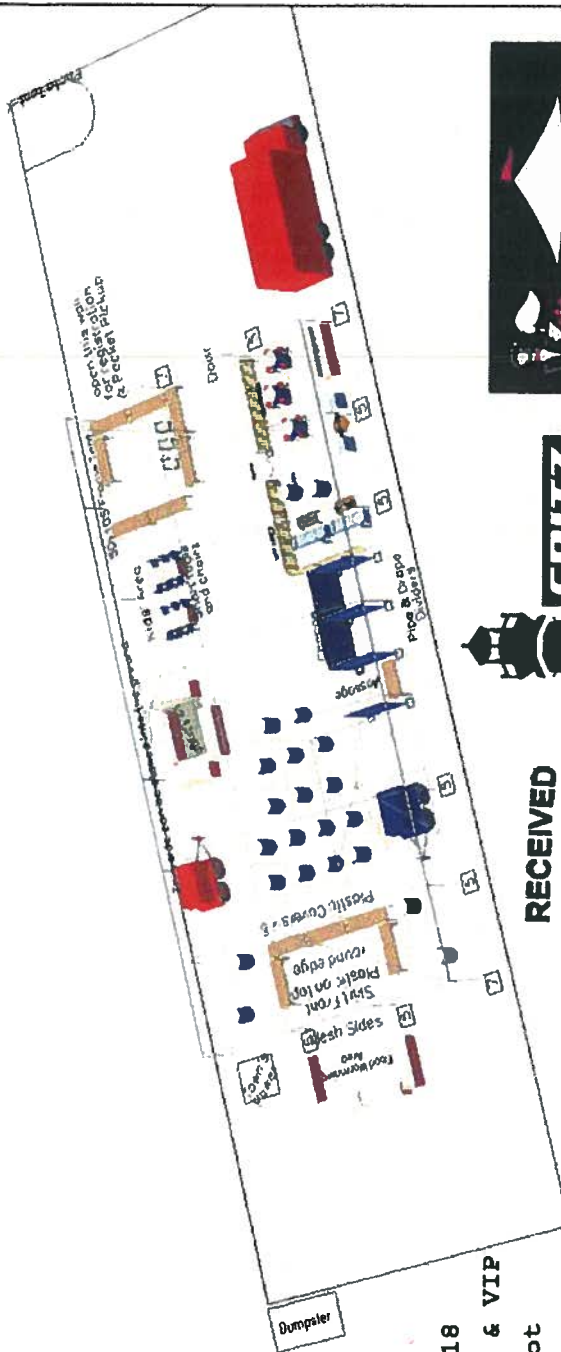
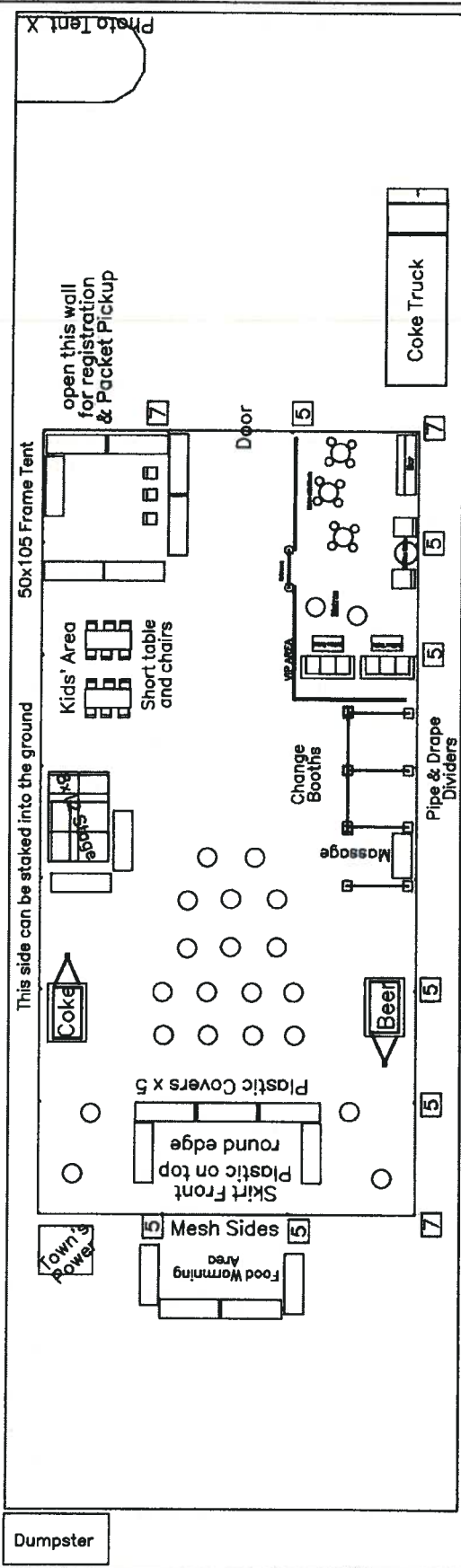
