Dear Ms. Bernzott:

This Letter of Permission (LOP) is in response to your request received on February 26, 2018 to host the 6th annual Tybee Island Kite Festival on the north beach area of Tybee Island. The project will begin no sooner than Sunday, April 29, 2018 and be completed the same day. Your request includes the placement of four (4) 10 ft. x 10 ft. tents with associated tables and chairs, as well as signage in the vicinity of the north beach parking lot. The dry sand beach seaward of the dunes will be included in the festival area. All amenities and signage will be removed as soon as the festival is complete.

The Department authorizes the temporary placement of festival amenities and signage as depicted in the attached project description and location map. Best Management Practices (BMPs) should be used to prevent any additional impacts at the site and to protect the shore jurisdictional areas. **No unauthorized equipment, materials or debris may be placed, disposed of, or stored in jurisdictional areas.** Any incidental impacts associated with this project must be rectified by fully restoring areas to their pre-construction topographic and vegetative states. This LOP is valid for the above referenced project. Any change in the use, location, dimensions, or configuration of the approved project, without prior notification and approval from this office could result on the revocation of this permission and in the required removal of the materials and related structures. This project must comply with all other Federal, State, and local statutes, ordinances and regulations. 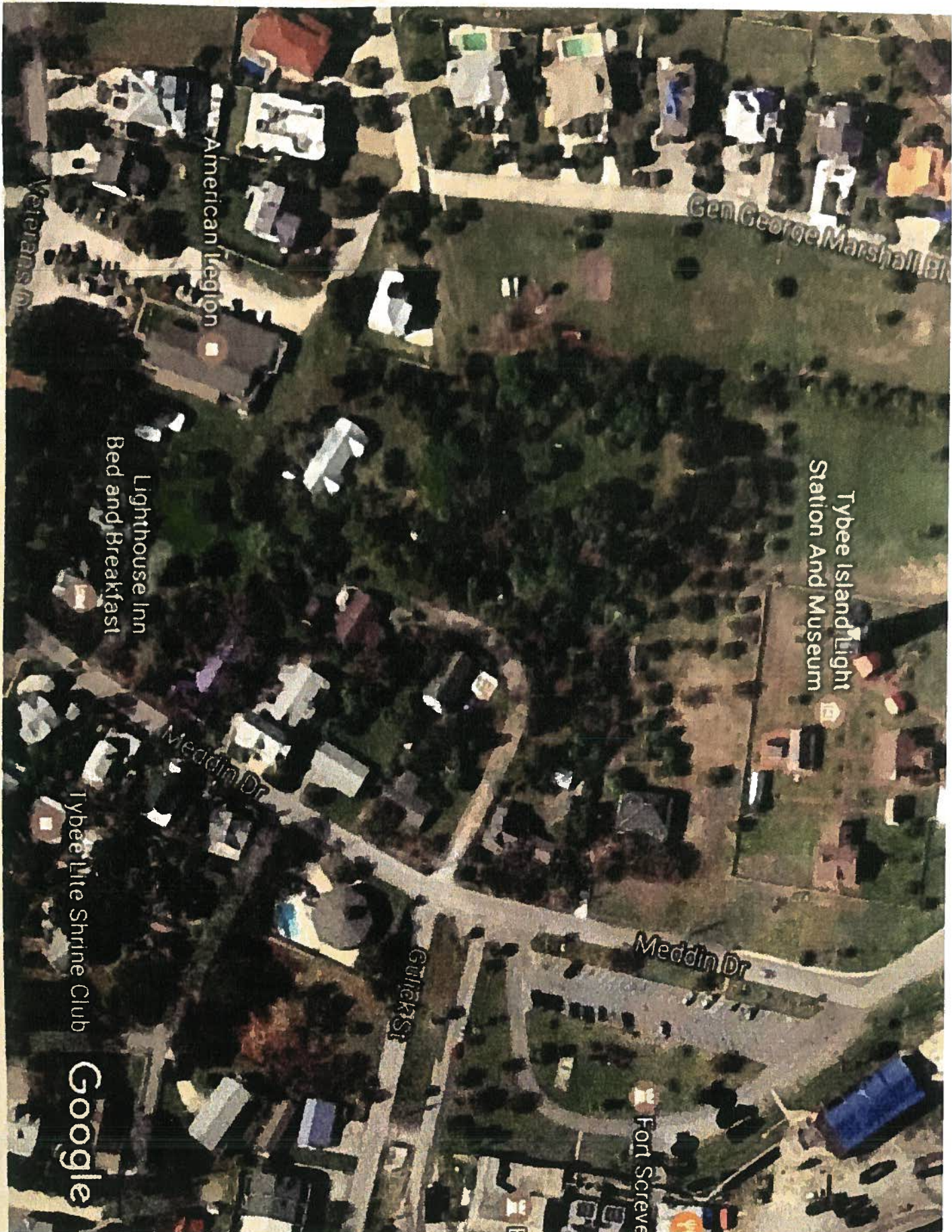
