The proposed activity includes the installation of a pedestrian walkway that will provide access to an upland portion of the lot that is currently inaccessible through the owner's property. Currently access is only afforded through the adjacent property driveway. The applicant has proposed a timber boardwalk that will not restrict the tide or significantly disturb aquatic life movements. With no impact to tidal or aquatic life movements no compensatory mitigation is proposed.

SUPPORTING REMARKS: Applicant is seeking CMPA authorization from Coastal Marshlands Protection Committee and verification from Savannah District Corps of Engineers to utilize Nationwide Permit 18 for the proposed activities. Applicant is selling a portion of his property to the Glynn County board of education, and as a result will lose the only existing access to the remainder of the property.
