Project Objective: Disperse aid allocated to Georgia's marine fishery participants experiencing

greater than 35% revenue loss.

Project Summary:

Based upon criteria developed by the Georgia Department of Natural Resources (GADNR) and approved by NOAA Fisheries, funds will be distributed to eligible commercial harvesters, processors, aquaculturists, and for-hire guides. Georgia has no known non-tribal subsistence fisheries therefore no funds have been set aside for that sector. Funds will be equitably distributed to all parties experiencing a revenue loss greater than 35% in June 2020 – June 2021 or March 2020 – June 2021 when compared to the same months 2015 - 2019. Any remaining funds will be equally distributed to crew. GADNR will directly contact known potential applicants and send press releases and social postings to reach any potential applicants that did not receive an application packet. Applications will be validated and applicants not meeting criteria will be notified and given an opportunity to appeal. After the application and appeals period has closed GADNR will calculate payments based on the total amount of loss and available funds. GADNR will forward recipient information and payment amounts to the Atlantic States Marine Fisheries Commission (ASMFC) for distribution. The methodology in the following detailed Spending Plan, once reviewed and approved by NOAA, may be used for any future funds appropriated by Congress for the same purpose.

Project Budget: \$2,959,612

Introduction

In March 2020 Congress authorized the Coronavirus Aid, Relief, and Economic Security Act (CARES) to provide economic assistance to American workers and businesses affected by the novel coronavirus (COVID-19). Section 12005 (a) of the act provided \$300 million of assistance commercial fishermen, charter businesses, qualified aquaculture operations, subsistence/cultural/ceremonial users, processors, and other fishery-related businesses affected by COVID-19, which could include direct relief payments. The Consolidated Appropriations Act of 2021 (The Act) made an additional \$300 million available to fisheries participants. NOAA Fisheries determined Georgia's allocation of the additional funds to be \$3 million before Hollings and other assessments. The ASMFC will be the grantee and will distribute funds based on Georgia's spending plan.

Although Georgia's commercial fishermen, seafood dealers, seafood processors, aquaculturists, and for-hire fishermen were not required to cease operations as part of Governor Kemp's Executive Orders, these sectors still suffered economic losses. Due to market and restaurant closures both in and outside of Georgia, seafood industry participants were unable to sell their products. Voluntary marina closures and trip cancellations negatively impacted for-hire operators.

Discussion

NOAA determined each state's allocation of aid for the for-hire fishing, commercial fishing and aquaculture, and seafood processing sectors. Of Georgia's allocation, 71.8% of the total revenues across all sectors for the state were from the seafood processing sector, presumably due to the presence of two large-scale processors owned by corporations outside of Georgia. Although these processors use very little, if any, domestic products they are eligible to apply for aid under the terms of the The Act. NOAA Fisheries guidance states, "Specifically, allocated funds are not required to be distributed based on the proportions outlined below." Given that flexibility, Georgia has opted to allocate no more than 25% or \$731,799 to processors. The remaining 75% will be distributed to the for-hire and harvester sectors. Should claims from the processing sector be less than \$731799 those funds will be diverted to harvesters and for-hire participants. If funds remain after for-hire, harvesters, and processors are paid, payments will be made to crew. Processors in Georgia are licensed by the Georgia Department of Agriculture with a license universe containing not only processors but grocery stores, small retail markets, and mobile sales. Due to the sheer number of license holders in relation to the potential applicants, GADNR will place legal ads in papers of record in the coastal region and metro Atlanta.

As outlined in guidance from NOAA Fisheries, bait and tackle businesses, while arguably fishery-related, may be excluded, "For the purposes of carrying out the provisions in Section 12005 of the CARES Act, "fishery-related businesses" should be limited to commercial fishing businesses, charter/for-hire fishing businesses, qualified aquaculture operations, processors, and dealers. Businesses farther down the supply chain—including vessel repair businesses, restaurants, or seafood retailers—are not considered "fishery-related businesses" for the purposes of this funding. NOAA Fisheries generally does not expect bait and tackle operations and gear and vessel

suppliers to be eligible for Section 12005 funding." GADNR has chosen to exclude bait and tackle, gear, and vessel suppliers. There are hundreds of businesses that sell fishing tackle in addition to other goods. GADNR has no source to verify data from these types of retail businesses, which would preclude verification of loss.

GADNR staff met with the 41-member Marine Fisheries Advisory Council (MFAC) on June 30, 2020 to discuss the proposed CARES spending plan. The MFAC is composed of four advisory panels with members from all sectors of Georgia's recreational and commercial fishing interests. The option of making flat payments to all license holders was discussed but ultimately was dismissed as being problematic and unfair. GADNR will adhere to the same recommendations for dispersing funds from The Act. CARES paid recipients for losses incurred March – May 2020. Those recipients may apply for losses greater than 35% incurred for the periods June 2020 – Dec. 2020, and/or Jan. 2021 - June 2021. Individuals who did not receive CARES funds will have four options:

- March 2020 Dec. 2020, and/or Jan. 2021 June 2021, or;
- June 2020 Dec. 2020, and/or Jan. 2021 June 2021

It will be the responsibility of the applicant to determine which application time frames (s) to use based on which period(s) they've incurred a greater than 35% loss. In order to simplify the "more than whole" calculation, applicants will be required to complete two applications, one for 2020 losses and another for 2021 losses. This would allow individuals/businesses to ensure they have not been made more than whole for losses incurred in the respective calendar year regardless of when they receive the payment.

If funds remain after for-hire, commercial, and processing applicants are paid, payments will be made to crew. Because many of these potential applicants are not required to purchase a Georgia license, acceptable documentation of fishery-related employment will include a 1099, W-2, Schedule C, or paycheck stub from a fishing operation. Applicants will be required to attest they have incurred a revenue loss greater than 35% for the period in which they are applying as compared to the same months 2015 – 2019. Payments will be equally distributed to all crew applicants based upon available funds.

Eligibility Criteria

To be eligible, applicants must meet the following requirements:

- 1) Residency: Georgia resident; and
- 2) Licensure:
 - a) Must have held a GADNR commercial fishing license (aquaculturists must have this license), GADNR Commercial Vessel License, GADNR saltwater guide license, GADNR seafood dealer license, or Georgia Department of Agriculture seafood dealer license, in the 2019 or 2020 license year; or
 - b) Provide proof of licensure in another state; or

- c) Worked as crew covered by a blanket license or otherwise not required to have a license; or
- d) Must be a Georgia Department of Agriculture licensed seafood processor and have been in business for at least one year; and
- 3) If the applicant is a commercial seafood harvester, must have reported landings in at least one year between 2015 and 2019; and
- 4) Have suffered economic revenue losses greater than 35%:
 - a) March 2020 December 2020 or June 2020 December 2020 and/or;
 - b) January 2021 June 2021 as compared to the same months 2015 2019. Newer fishery participants with fewer than five years of activity will compare losses to the number of active years; and
- 5) Have not been made more than whole by exceeding the average revenue earned across 2015 2019 through the combination of this funding, any other COVID-19 related assistance and/or any traditional revenue.

Procedure

Georgia was allocated \$3 million, however, administrative fees for NOAA, ASMFC, and GADNR will reduce the available direct payment amount to \$2,927,195(see budget).

GADNR will send an application via certified mail to known fishery participants based upon license sales and landings reports. Also, social media postings, press releases and legal advertisements in coastal and metro Atlanta newspapers will be made to alert potential eligible participants to the availability of aid.

To distribute aid as quickly as possible, GADNR will request applicants sign affidavits attesting to revenue loss as well as disclosure of other federal and/or state COVID economic relief aid. This affidavit will be part of the application package. A worksheet will be provided to record monthly revenue for March 2020 – Dec. 2020, and/or Jan. 2021 – June 2021, or June 2020 - Dec. 2020, and/or Jan. 2021 – June 2021, for the >35% loss period(s) selected, and to help calculate the percentage of loss. Applicants may choose to claim any or all months within the loss periods as long as the claim consists of at least 28 consecutive days. Applicants will then return the worksheet, affidavit, and proof of residency in the form of a valid Georgia driver's license or Georgia ID card, to GADNR. Georgia law defines a resident as someone having resided in Georgia for three months or more. Applicants will be given 30 days to submit their request.

Upon receiving a completed application package, GADNR staff will review applications for completeness by verifying licensure against the license database, checking that residency documents meet the requirement, and checking worksheet calculations. Incomplete applications will be returned via certified mail and the applicant will be given 15 days from the receipt date to re-submit. Ineligible applicants will receive a certified denial notification and given 15 days from the receipt date to submit an appeal. Actual dates are dependent upon approval of the spending plan by NOAA.

After the appeals period has closed, an appeals board comprised of four members of the MFAC and the GADNR Coastal Resources Division (CRD) Director will convene for one day to review supporting documents. Inordinately high losses as compared to the value of the fishery, the applicant's revenue history, or falling outside of the 95% confidence interval of all aid amounts will be verified by reported landings or through a request to examine trip records.

Aid Determination

Once all applications are received, reviewed, and verified, GADNR will record revenue loss for each eligible individual and determine the proportion each loss represents of the combined total loss of all eligible individuals. Except as stated above for processors, no minimum or maximum payment limits will be applied. If the total revenue loss is less than the \$2.92 million, individuals will be paid for the exact amount of their loss. If the total revenue loss exceeds the \$2.92 million, the individual's proportion will be applied to the award amount to determine aid. Upon verification and completion of appeals, recipient information including award amount will be forwarded to ASMFC for payment.

Budget

Georgia was allocated \$3 million; however, after NOAA and ASMFC administrative fees, \$2,959,612 remains. GADNR will assume an administrative fee of \$32,417 thereby reducing the available assistance to fishermen to \$2,927,195.
