Re: Letter of Permission (LOP), Temporary Tent and Activities, Beachview Club Hotel, Jekyll Island, Glynn County, Georgia GPS: (31.070033°N/81.403873°W)

Dear Ms. Taylor:

This Letter of Permission (LOP) is in response to your request, received July 26, 2018, for the proposed temporary tent and activities associated with a wedding within the Shore Protection Act (SPA) jurisdictional area at Beachview Club Hotel, Jekyll Island, Georgia. The event will occur on the lawn area seaward of the parking lot and landward of the sidewalk. Event set up will begin on Friday October 19, 2018 between 9:00 AM and 5:00 PM. Equipment to be used includes a 40ft. x 80ft. pole tent, tables, chairs, a 12ft. x 16ft. stage for a band, and a 12ft. x 15ft. dance floor. An electric cable will run to the existing cable box for the band. The pole tent will be setup by hand and with a gas-powered stake driver. The wedding event will occur on Saturday October 20, 2018 between 8:00 AM and 5:00 PM. All equipment for the event will be disassembled on Monday October 22, 2018 between 9:00 AM and 5:00 PM. The project will begin no sooner than October 19, 2018 and must be completed no later than October 22, 2018.

The Department authorizes for the proposed temporary tent and activities associated with a wedding within the SPA jurisdictional area as described above and depicted in the attached description, provided all Best Management Practices (BMPs) be used to protect jurisdictional shore areas. No equipment, materials or debris may be placed, disposed of, or stored in jurisdictional areas. Any incidental impacts associated with this project must be rectified by fully restoring areas to their pre-construction topographic and vegetative states. Any change in the use, location, dimensions, or configuration of the approved project, without prior notification and approval from this office could result in the revocation of this permission and in the required removal of the related structures. This LOP does not relieve you from obtaining any other federal, state, or local permits. If you have any questions, you may contact Jordan Dodson at (912) 262-3109.
