Re: Letter of Permission (LOP) for the Maintenance of an Existing Culvert On Dover Bluff Road, Camden County, Georgia (GPS: 31.027690°N, 81.534223°W)

Dear Mr. Boatright:

This Letter of Permission (LOP) is in response to your request, received September 26, 2018 on behalf of the Camden County Board of Commissioners, for the maintenance of an existing concrete culvert/pipe adjacent to coastal marshlands on Dover Bluff Road, Camden County, Georgia. The existing concrete pipe runs beneath Dover Bluff Road and was damaged during Hurricane Irma and is causing erosion beneath and adjacent to Dover Bluff Road. The project includes the placement of a liner pipe (40" HDPE Pipe) within the existing 48" concrete pipe. Once the liner pipe is placed within the existing, the void between the new liner pipe and the existing pipe will be filled with concrete to stabilize the structure and prevent further erosion under and adjacent to Dover Bluff Road. There will be no increase to the size of the existing infrastructure, and the work will be confined to the existing footprint of the structure. The project will begin no sooner than 15 days from the date of this letter and must be complete within six (6) months.

The Department authorizes the maintenance of the existing culvert/pipe as depicted in the attached description and has no objection to the action, provided Best Management Practices (BMP's) are used. All debris must be disposed of at an appropriate upland location. No unauthorized equipment, materials or debris may be placed, disposed of, or stored in jurisdictional areas. Any incidental impacts associated with this project must be rectified by fully restoring areas to their pre-construction topographic and vegetative states. This LOP is valid for the above referenced projects. Any change in the use, location, dimensions, or configuration of the approved project, without prior notification and approval from this office could result in revocation of this permission and in the required removal of the related structures. This LOP does not relieve you from obtaining any other federal, state, or local permits. Dover Bluff Pipe Issue-Proposal

Jordan,

Located at the coordinates of 31.027690, -81.534223 on Dover Bluff Road, East of I-95, Camden County would like to place a liner pipe (40" HDPE Pipe), within the existing 48" concrete pipe. Upon placing the liner pipe within the existing pipe, Camden County will then fill in the void between the liner pipe and the existing pipe with concrete to close off any void. The reason for this is due to the existing pipe causing the soil above the pipe to wash out from beneath the asphalt. Due to the voids below the existing asphalt, we have recently filled in the void with fill dirt and cold mix for a temporary fix.


This damage was caused during Hurricane Irma and was not initially noticed because everything was under the asphalt. Over time the soil beneath the asphalt and around the pipe has washed out causing the pavement to collapse. By placing the liner pipe within the existing pipe and filling in the voids with concrete/cement, Camden County will stop any further erosion from around the existing pipe joints. We will not increase the size of any of the existing infrastructure within this process and may seek bids for this project.
