Re: Letter of Permission (LOP), EVP Pro-Am Beach Volleyball Tournament in the State's Shore Protection Act (SPA) Jurisdiction, Tybee Beach North of Tybee Pier, Atlantic Ocean, Tybee Island, Chatham County, Georgia

Dear Mr. Balling:

This Letter of Permission (LOP) is in response to your request to temporarily place volleyball courts, seating, a stage and associated sound system, sponsor signs, inflatable elements, and tents within the State's Shore Protection Act Jurisdiction area on the beach just north of the Tybee Pier in conjunction with the EVP Pro-Am Volleyball Tournament scheduled May 11 & 12, 2019. The temporary project will begin no sooner than May 10, 2019 and be completed no later than May 12, 2019.

As proposed, your request includes the temporary installation of all necessary equipment as outlined in the attached event schedule and site plan. All event equipment will be delivered to the 14th Street parking lot and transported onto the beach using the most convenient dune crossover in the parking lot. This includes the temporary installation of nineteen (19) 70ft. x 40ft. volleyball courts, four (4) 10ft. x 10ft. tents, two (2) 10ft. x 20ft. tents, two hundred (200) chairs, one (1) inflatable positions, one (1) sound system including two (2) speakers, one (1) 12ft. x 16ft. stage and twenty-eight (28) 2ft. x 8ft. court side sponsor signs. Set-up will begin at 7am on Friday May 10, 2019. Tournament matches will begin at 8am, Saturday May 11, 2019 and end 6pm Sunday, May 12, 2019. Limited set removal will start 6pm to 8pm Saturday. Complete set removal will be from 6pm to 8pm on Sunday, May 12, 2019.

The Department authorizes the placement of equipment as depicted in the attached description and has no objection to the action provided Best Management Practices (BMP's), as required by the City of Tybee Island, are used to prevent any additional impacts at the site and to protect jurisdictional shore areas. The proposed equipment must be installed using hand tools only.

This Letter of Permission is not meant to exempt the above referenced activity from future environmental laws. **No unauthorized equipment, materials or debris may be placed, disposed of, or stored in jurisdictional areas.** Any incidental impacts associated with this project must be rectified by fully restoring areas to their pre-construction topographic and vegetative states. This LOP is valid for the above referenced project. Any change in the use,

location, dimensions, or configuration of the approved project, without prior notification and approval from this office could result in the revocation of this permission and in the required removal of the related structures. This project must comply with all other Federal, State, and local statutes, ordinances and regulations.

In coordination with the Tybee Ocean Rescue and the Tybee Police Department, an 8-10ft. wide path must be available along the high water mark for emergency vehicle access along the beach. During the event, public access must be maintained through the public crossovers in the area and along the high water mark.

Because the project occurs between May 1st and October 31st, turtle nesting season, an individual with a DNR Sea Turtle Cooperators Permit must survey the area to be used by the equipment prior to the work beginning. All sea turtle nests must be avoided and no activity may occur within 20ft. of a nest area.
