This Letter of Permission (LOP) is in response to your request, received June 22, 2022, to install and maintain approximately 200 linear feet of sand fencing. Sand fencing will be installed as depicted in the attached description to protect the cottage and garage on Lot 49, Little Cumberland Island. The installation of sand fencing within SPA Jurisdiction will begin no sooner than 15 days from the date of this letter and be installed within 6 months.

The Department authorizes the installation of sand fencing within SPA Jurisdiction, as depicted in the attached description and drawings. No unauthorized equipment, materials, or debris may be placed in, disposed of, or stored in jurisdictional areas. Any incidental damage to dunes or dune vegetation will require restoration to be coordinated through this office. This LOP is valid for the above referenced project. Any change in the use, location, dimensions, or configuration of the approved project, without prior notification and approval from this office could result in revocation of this permission and in the required removal of the related structures. If at any point the fencing becomes compromised, the affected sections shall be removed.
