## Re: Letter of Permission (LOP), Activities within the State's Shore Protection Act (SPA) Jurisdiction, New Year's Eve Event, South Beach, Tybee Island, Chatham County, Georgia

Dear Ms. Webster:

This Letter of Permission (LOP) is in response to your request received November 8, 2022 to host the New Year's Eve Event on the South Beach area of Tybee Island. This is a one-day event that will occur Saturday, December 31, 2022.

Your request includes the placement of temporary crowd control measures to create a fireworks safety zone in association with the 2022 New Year's Eve event scheduled December 31, 2022. Working in conjunction with the Tybee Island Police Department, the safety zone will be created the day of the event to secure the area immediately north and south of the Tybee Pier & Pavilion. The public will be able to traverse the beach landward of fireworks safety zone throughout the day and spectators will be able to observe the fireworks from a controlled distance. The fireworks safety zone will be delineated using City of Tybee Island Police traffic cones that will be set up the day of the event and removed upon event conclusion. To prevent and minimize marine debris associated with the display, all debris must be removed immediately after the display is completed, this includes trash, zip ties, and spent fireworks that land on the beach or pier at the conclusion of the event. All pyrotechnic debris must be disposed of in a fire-safe container and removed from the public beach at the end of the event.

The Department authorizes the temporary activities associated with the events as depicted in the attached project description and location map. This LOP is not meant to exempt the above referenced activities from future environmental laws. **No unauthorized equipment, materials, or debris may be placed, disposed of, or stored in jurisdictional areas.** Any incidental impacts associated with this project must be rectified by fully restoring areas to their preconstruction topographic and vegetative states. This LOP is valid for the above referenced projects.



## 2022 Beach Permit needed for below event.

- 1. New Year's Eve Saturday, December 31st:
  - Fireworks on the Pier at midnight
  - Fireworks and cone setup approximately at 8:00-10:00a.m. and teardown at approximately 12:15a.m. to 1:00a.m.
  - Tybee Police will block off the fire safety zone around the Pier with cones and secure it throughout the day approximately 420ft from the fireworks. (See attached diagram)
  - I will purchase the same red glow stick for the police to use to secure the Fireworks Zone and make it safe in the dark.



Fireworks Safety Zone:

To be determined by the fireworks contract (approximately 420 ft.) radius from the fireworks will be blocked off with cones/stanchions with rope by the Tybee Island Police Department. The Tybee Police will secure the area while the fireworks are on the Pier. Red glow sticks will be around the blocked off area.
