Re: Letter of Permission (LOP), Temporary Activities within the State's Shore Protection Act (SPA) Jurisdiction, Tybee Island Pirate Fest, South Beach Area, Tybee Island, Chatham County, Georgia

Dear Ms. Murray:

This Letter of Permission (LOP) is in response to your request to host the Tybee Island Pirate Fest in the South Beach parking area. Setup for the 2023 Tybee Island Pirate Fest will commence no sooner than 15 days after the date on this letter and be completed no later than Sunday October 8, 2023.

Your request includes the temporary placement of amenities to create a festival zone in association with Tybee Island Pirate Fest in the parking area south of the Tybee Pier and Pavilion. Thursday, October 5 through Sunday, October 8, 2023. All activities will occur within the confines of the paved parking area, roundabout, and sidewalks landward of the sand dunes.

The request includes a festival zone with vendor tents, an entertainment stage, children's activities, and tempory restrooms. The roundabout and the northern entrance to the parking lot will be closed to vehicular traffic. All vehicular traffic on 16<sup>th</sup> Street will be diverted to The Strand. Within the roundabout there will be two (2) 10ft. x 10ft. tents for vendors, one (1) portable restroom, one (1) pirate ship themed vessel on an 24ft. trailer, and main stage that measures approximately 18ft. x 20ft. with an associated sound truck. The festival zone within the footprint of the existing parking lot to the south will host four (4) portable restrooms, two (2) 28ft. x 14ft. bounce houses, one (1) 20ft. x 20ft. shark exhibit, one (1) 16ft. x 19ft. performance stage, and eighteen (18) 10ft. x 10ft. vendor tents with associated tables and chairs for vendors and patrons within the festival zone. The festival zone will be identified by event banners and flags and will be serviced by existing power infrastructure. No generators are proposed to power any associated amenities. The festival zone and entertainment area are depicted in the attached plans.

All zip ties associated with the installation of the festival zones must be collected, placed in appropriate trash receptacles, and removed from the public area during breakdown. No impacts to the sand sharing system are proposed and access to the beach is available to the public at existing crossovers along The Strand.

The Department authorizes the temporary activities associated with the events as depicted in the attached project 2023 Event Site Plan. It is the applicant's responsibility to minimize any additional impacts at the site and to protect the shore jurisdictional areas.

This LOP is not meant to exempt the above referenced activities from future environmental laws. No unauthorized equipment, materials or debris may be placed, disposed of, or stored in jurisdictional areas. Any incidental impacts associated with this project must be rectified by fully restoring areas to their pre-construction topographic and vegetative states. This LOP is valid for the above referenced project only.


