Re: Letter of Permission (LOP), Temporary Activities, Placement of a Fireworks Display, Vicinity of King and Prince Resort, 201 Arnold Road, St. Simons Island, Atlantic Ocean, Glynn County, Georgia, (GPS 31.13915°N/-81.37815°W)

Dear Munnerlyn Pyrotechnics:

This Letter of Permission (LOP) is in response to your request, dated November 22, 2024, to set up equipment for a Fireworks Display on the beach at The King and Prince Beach and Golf Resort, within Shore Protection Act (SPA) jurisdiction on December 21, 2024.

To accomplish the set-up, a flatbed trailer will be hauled onto the beach with a one ton 4-wheel drive pick-up truck. The flatbed trailer will serve as the firework launch site and will be located at one of the three locations depicted in the attached description and site maps dependent on tide and wind. All event activities will take place landward of the Ordinary High-Water Mark and seaward of the dunes.

During the fireworks display, local fire and emergency response vehicles will be parked within 100 yards of the shoot site location. A second pickup truck will also be parked near the flatbed trailer to run staff and supplies to and from the launch site. The equipment and vehicles will travel to the launch site via the DNR approved vehicle access points located at the Coast Guard Beach and Massengale Park.

To secure a 145ft. safety zone, a fence consisting of red metal posts driven into the sand and caution tape strung from post to post will be temporarily installed around the launch site. Directional signage will be tied directly to the fence posts and used in conjunction with Munnerlyn Pyrotechnics staff to prevent pedestrians from entering the safety zone.

Munnerlyn Pyrotechnics staff will begin set up on the afternoon of December 21, 2024, and position the flatbed trailer above the wrack line and seaward of the sand dunes. Removal will take place immediately following the event. All materials, equipment, litter, and debris will be removed. In the event of rain or other unforeseen events, set up and removal will occur between December 21, 2024 and December 22, 2024. No dunes or dune vegetation will be disturbed during the transport or set up of any of the structures.

The Department authorizes the placement of the fireworks set up equipment as depicted in the attached description and site map and has no objection to the action. **No unauthorized equipment, materials or debris may be placed, disposed of, or stored in jurisdictional areas.** Any incidental damage to dunes or dune vegetation will require restoration to be coordinated through this office. This LOP is valid for the above referenced project. Any change in the use, location, dimensions, or configuration of the approved project, without prior notification and approval from this office could result in revocation of this permission and in the required removal of the related structures.

To Whom it May Concern,

Munnerlyn Pyrotechnics would like to request permission and use of the beach located at The King & Prince Beach & Golf Resort 201 Arnold Rd., St. Simons Island GA for a fireworks display scheduled on 12/21/2024. The event will feature a professionally coordinated firework show conducted by Munnerlyn Pyrotechnics and its licensed pyrotechnicians. We will ensure that all necessary safety precautions are in place, including a designated safety perimeter, crowd control, and post-event cleanup. The display will follow all local regulations, and we are prepared to collaborate with local law enforcement and fire departments to ensure public safety.

1. Site Setup: Identify and prepare designated launch zones, spectator areas, and safety perimeters. **See Site Map Attached**

2. Pyrotechnics Setup: Arrange and secure fireworks at launch sites following fire safety regulations.

3. Safety Inspections: Perform pre-show inspections of launch equipment, fire extinguishers, and emergency response measures.

4. Launch Coordination: Manage the timing of fireworks display sequences.

5. Crowd Management: Ensure proper signage, barriers, and personnel to guide spectators and control entry.

6. Post-Display Clean-Up: Remove fireworks debris and perform a safety check of the site.

Fireworks Setup and Launch

King & Prince Beach Resort

Date: 12/21/2024

-Time: Setup from 1:00 PM to 8:00 PM, fireworks launch at 9:00 PM.

- Munnerlyn Pyrotechnics will need to haul a flatbed trailer onto the beach which staff will utilize as a platform to launch this firework display. The trailer will be brought to the site in the early afternoon around 1pm on 12/21/24 via our approved access ramp which is located about 800-1,100 yards North of the launch site. The flatbed trailer will be primarily hauled to the site with a 1 ton 4 wd pickup truck.

- Trailer will be removed from the site in the same manner. The trailer will serve as the launch site and will be located approximately 100 yards Southeast of the King and Prince Beach Resort. Crews will only work on setting up the fireworks during daylight hours and no additional artificial light sources will be present on the beach at night. To secure a 145ft wide safety zone around the launch site, red medal posts will be driven into the sand with caution tape attached. The post and caution tape will be installed to prevent pedestrians from entering the safety zone. Additional temporary directional signage will be tied directly to the posts. In addition to the flatbed trailer, one pickup truck will be parked near the trailer to run staff and supplies to and from the launch site.

-All guests in attendance to watch the fireworks display will be located at the King & Prince Beach Resort, or on the public beach that lies outside of the safety zone. Staff will patrol the entire event site to prevent guests from entering the shoot site and to safeguard any sea turtle nest sites. All event activities All event activities will take place landward of the ordinary of the high water mark and seaward of the dunes and there will be no disruption to the adjacent primary beach by vehicles or staff assembling the launch pad and site or during its removal at the conclusion of the event. Full completion of this scope of work will be installed and removed on the same day.

-All fire trucks and other emergency vehicles will be parked nearby within 100 yards of the shoot site location (see site map), well away from any of the nearby dune habitats if any and well outside of the jurisdiction area.

-Activity Details: Licensed pyrotechnicians will place fireworks in pre-designated launch zones, ensuring proper setup (fireworks being used in this event will be a combination of 1.3 & 1.4 cakes – No Mortars.) A test fire will be conducted to ensure equipment functionality. The fireworks display will involve multiple aerial cakes.

-Safety Measures: A 145-foot perimeter will be established around the launch area. Fire extinguishers and emergency medical personnel will be on-site.

These activities ensure a safe and organized fireworks event


