Re: Letter of Permission (LOP), Temporary Activities within the State's Shore Protection Act (SPA) Jurisdiction, Orange Crush 2025, South Beach Area, Tybee Island, Chatham County, Georgia

Dear Mr. Smalls:

This Letter of Permission (LOP) is in response to your request to host a music festival associated with Orange Crush 2025 (OC) on South Beach, Tybee Island. Set up and breakdown for the one-day event will commence no sooner sunrise Saturday, April 19, 2025. All event amenities will be removed from the beach at the end of the show the same day.

The project includes the temporary placement of amenities associated with a one-day music festival on the dry sand beach north of the Tybee Pier and Pavilion towards the 14th 1/2 Street public dune crosswalk. All amenities in association with Orange Crush 2025 music festival will be temporarily installed not less than 20ft. seaward of the seaward toe of the most seaward dune and landward of the ordinary high-water mark. The festival zone will include a stage, sound system, tents, trash collection centers, and event amenities for festival participants.

Festival amenities north of the Pier and Pavilion will include one (1) 32ft. x 24ft. stage for performers with an associated 10ft. x 10ft. catwalk. According to the site plan, there will as many as seventeen (17) 10ft. x10ft. pop up tents with associated tables and chairs for vendors and patrons within the festival zone. Additionally, four (4) 20ft. x 40ft. tents and four (4) 20ft. x 60ft. with customized crowd barriers will be installed adjacent to the stage to create VIP areas. One (1) 20ft. x 60ft. artist tent will be erected for talent north of the stage. The stage and event audio equipment will be powered by a generator located in the 14th Street parking lot. In an effort to minimize risks to public safety, all electrical power lines associated with audio system will be bundled, identified, and secured appropriately.

All event amenities will be transported using hand carts via existing dune crosswalks the day of the event. A temporary mat may be installed seaward of the dune crosswalk at 14th ½ Street to facilitate transport of equipment. When installed, event amenities can be no closer than 20ft. seaward of the existing sand fence in the festival zone. No gas or diesel generators are authorized for use or storage in SPA jurisdiction. No vehicles or vehicular equipment is authorized on the beach in connection with this LOP. All work must be accomplished using hand tools only.

To protect sand dunes from unintended impacts, the event coordinator must clearly identify the landward limits of the festival area to prohibit foot traffic in the area landward of the existing

sand fence in the festival zone. This will be accomplished by installing temporary signage to identify and limit ingress & egress to the dune field. During the event, OC staff will patrol the beach to monitor activity and collect trash. After the festival is over, OC staff will canvas the beach collecting trash and restoring the area to its pre-event topographic condition. The use of vehicles on the beach is prohibited in association with the event.

All zip ties associated with the temporary installation of the festival zones must be collected, placed in appropriate trash receptacles, and removed from the beach during breakdown. No additional impacts to the sand sharing system are approved and access to the beach is available to the public north and south of the festival zone.

The Department authorizes the temporary activities associated with the events as depicted in the attached OC 2025 Event Site Plan. It is the applicant's responsibility to minimize any additional impacts at the site and to protect the shore jurisdictional areas.

This LOP is valid for the above referenced project only. Any change in the use, location, dimensions, or configuration of the approved project, without prior notification and approval from this office could result in the revocation of this LOP and in the required removal of the materials and related structures. **No unauthorized equipment, materials or debris may be placed, disposed of, or stored in jurisdictional areas.** Any incidental impacts associated with this project must be rectified by fully restoring areas to their pre-construction topographic and vegetative states. This project must comply with all other Federal, State, and local statutes, ordinances and regulations.




