Re: Letter of Permission (LOP), 2023 Critz Tybee Run Fest, Activities within the State's Shore Protection Act Jurisdiction, South Beach Parking Lot & 16th Street Roundabout, Tybee Island, Chatham County, Georgia

Dear Ms. Horst:

This Letter of Permission (LOP) is in response to your request to host the 2023 Critz Tybee Run Fest in the South Beach parking lot on Tybee Island. This event combines multiple courses for participants over a two-day period. The temporary project within the State's Shore Protection Act (SPA) Jurisdiction will commence no sooner than 15 days after the date on this letter and be completed no later than Saturday, February 5, 2023.

Your request includes the placement of event amenities on the paved areas associated with the roundabout on 16th Street and the Strand parking lot to the south. The parking lot will be closed Friday February 3, 2023, through post event clean up Saturday, February 4, 2023. Event amenities include one (1) 20ft. X 20ft. medical services tent, and one (1) 105ft. X 50ft. tent that will provide cover for, tables, chairs, generators, and other Critz Run Fest amenities for race participants. Additionally, a bounce house, one (1) dumpster and specialty vehicles offering race participants event amenities will be placed on the existing paved parking area located at 16th Street and Strand. Specialty trucks will also set up along the roundabout and in the parking lot to offer runners promotional items. The event will be set up Friday, February 4 and removed no later than Saturday, February 5, 2023. No amenities will be impact pedestrian use of the event area. All power cables will be identified and secured appropriately. All zip ties associated with the installation of the festival zone must be placed in appropriate trash receptacles and removed from the public area during breakdown.

The Department authorizes the temporary event facilities as depicted in the attached project description and location map. No impacts to the sand sharing system are proposed and access to the beach is available to the public at existing crossovers along the Strand. **No equipment, materials or debris may be placed, disposed of, or stored in jurisdictional areas.** Any incidental impacts associated with this project must be rectified by fully restoring areas to their pre-construction topographic and vegetative states.

This LOP is valid for the above referenced project. Any change in the use, location, dimensions, or configuration of the approved project, without prior notification and approval from this office could result in revocation of this permission and in the required removal of the materials and related structures. This project must comply with all other Federal, State, and local statutes, ordinances and regulations.

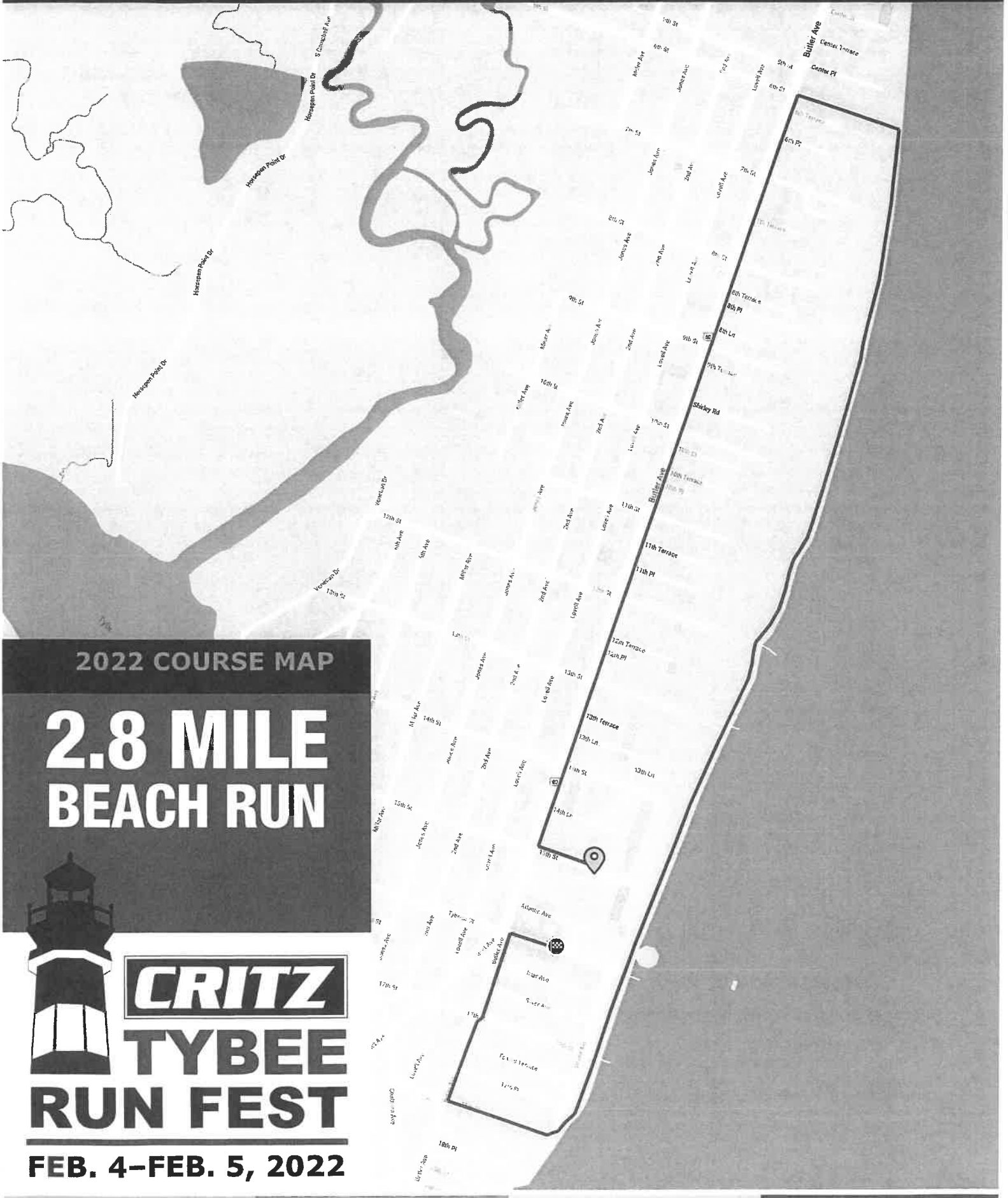

2022 COURSE MAP

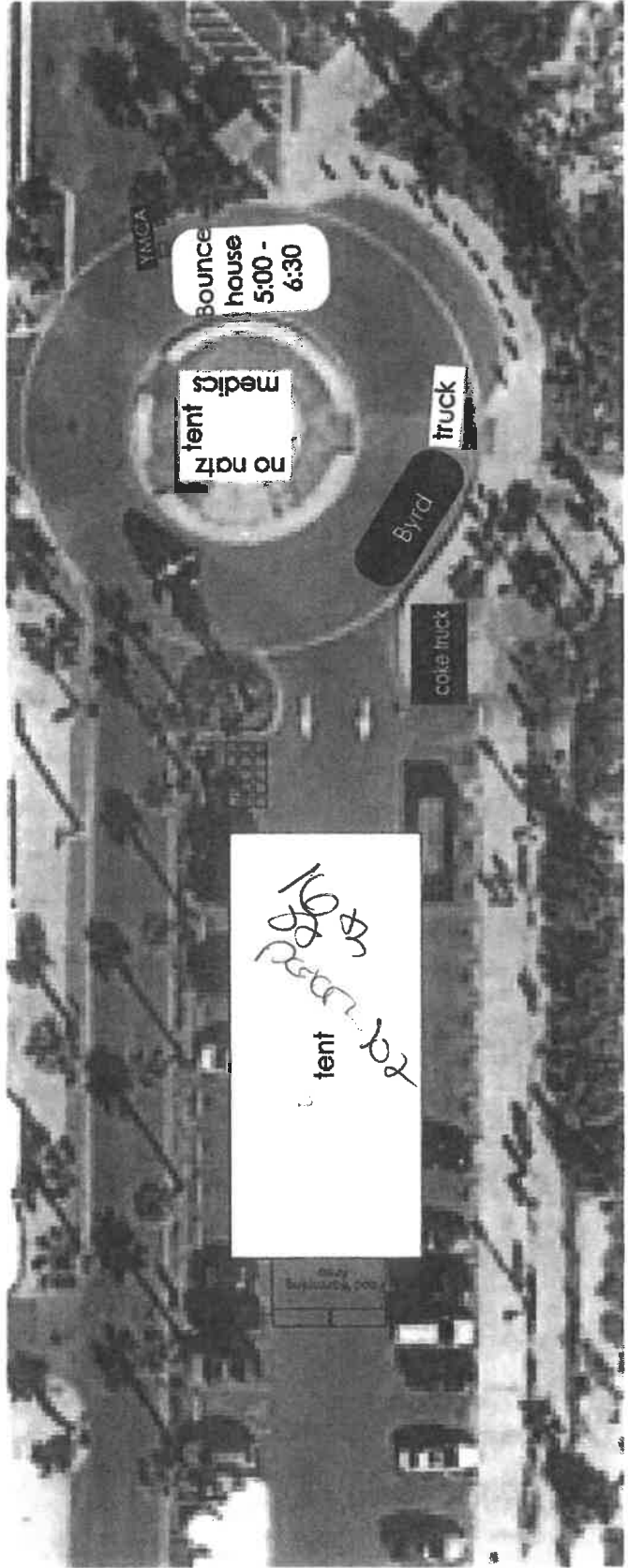
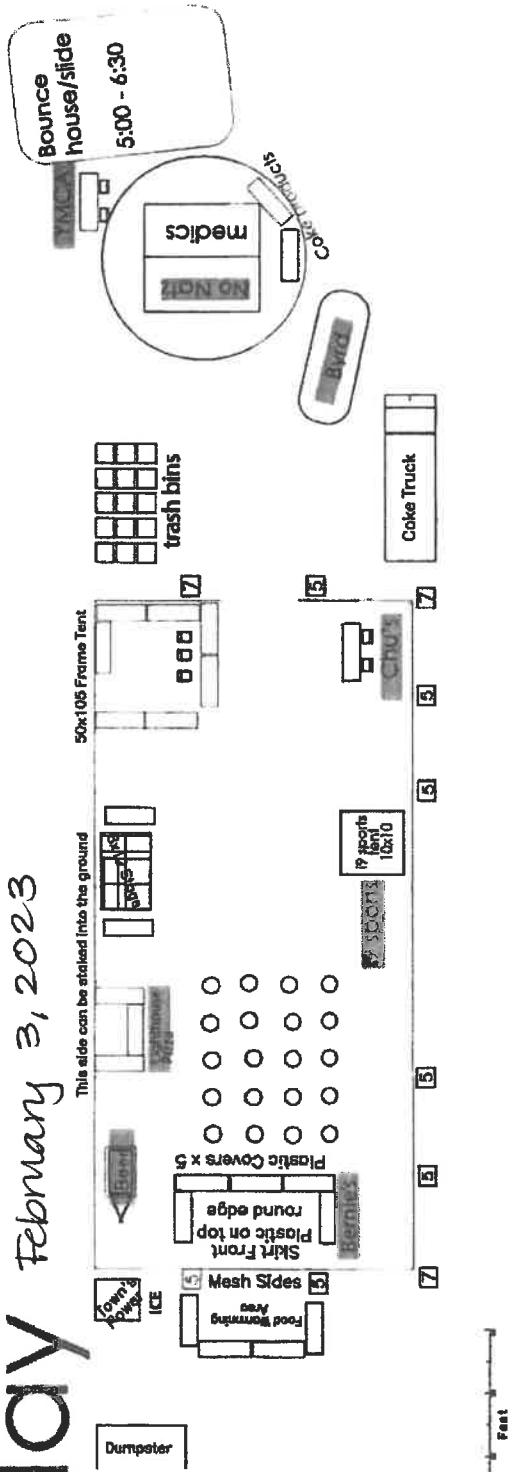
