Regulatory Process & Timeline

June 6 & 9 - Public Town Hall meetings conducted in Savannah and Brunswick *

August 23 – Briefing on proposed Red Drum regulation changes presented to the Board of Natural Resources *

August 24 – Public Notice issued announcing written comment period *

September 21 & 22 – Public hearings conducted in Savannah and Brunswick

October 6 – Public written comment period closes

October 25 – Final Action on proposed Red Drum regulation changes by the Board of Natural Resources

If approved - Effective January 1, 2023

CRD Red Drum Sampling Surveys and Programs

- Marine Sportfish Population Health Survey- samples smaller Red Drum with gillnets and trammel nets in Georgia estuaries
- Coastal Longline Survey- encounters large adult Red Drum offshore in state waters
- The Escapement Project- targets older juveniles in Georgia estuaries and the implanted acoustic tags can be detected outside of the state as fish age and emigrate from coastal waters
- Marine Sportfish Carcass Recovery Program- samples legal-sized fish from the recreational fishery within the state
- The Cooperative Angler Tagging Program- samples Red Drum of various sizes caught by anglers and provides information from both within and outside the state
- Marine Recreational Informational Program- dockside intercept survey gathers information about angler Red Drum catch and mail survey to estimate fishing effort (MRIP, state-federal partnership)


Data from these surveys and programs summarized Red Drum Status Reports (2021 & 2022).

Presented to CRD Finfish Advisory Panel & June Town Halls.

- Based on available biological data, no management action was necessary
- Tagging data estimated fishing mortality was low and suggested fish are escaping the fishery
- Red Drum indices were variable between years, but trends were relatively stable over time
- Indices tended to agree over time




Red Drum State Surveys & MRIP








Guide creel limit; Season; Slot size limit

- Prohibit guides/mates from retaining daily creel limit
 - This question was asked only at the Town Hall Meetings.
 - 75% of anglers and 83% of guides agreed that guides and their mates <u>should not retain</u> a creel limit.

• Fishing Season

• Both anglers and guides <u>opposed</u> a fishing season for Red Drum. <u>No change is being requested.</u>

• Slot Size Change

- Although both groups supported changing the slot limit size, currently 14"-23", the Department does not have enough information at present to analyze the effects of a change.
- A regional stock assessment will be conducted in 2024, the results of which can better inform this question.

Rationale for Recommended Regulation Changes

Regulations most often changed based on results of regional stock assessment.

- Red Drum 2002
- Weakfish

Additional reasons for change include supporting other management options.

• Increased abundance: Spotted Seatrout

Social Components must be part of the equation.

- Tripletail, Billfish
- Red Drum
 - Anglers have been requesting action for several years
 - Survey participants support a regulatory change
 - 40% increase in inshore angler trips
 - "Georgia continues to grow at greater than 1% per year, which makes it one of the faster growing states (12th) in the country" (<u>https://worldpopulationreview.com/states/georgia-population</u>).

Proposed Amended Rule 391-2-4-.04 Saltwater Finfishing

391-2-4-.04 (3) Seasons, Daily Creel and Possession Limits, Minimum and Maximum Size Limits.

(m) Red Drum	All Year	5- <u>3 per person not to</u> exceed 9 per boat	14 TL	23 TL			
1. Guides and mates are prohibited from retaining a daily creel or possession limit.							

- Help decrease large individual catches when immature Red Drum are vulnerable to fishing mortality
- Reduce the risk of localized overfishing

Both comment submission options ask whether you Support or Oppose: Action 1: Decrease the Red Drum daily creel limit from five (5) to three (3) fish. Action 2: Establish a vessel limit of nine (9) Red Drum. Action 3: Prohibit guides and mates from retaining their creel limit.

Both submission options also provide a space for comments for each action as well as general comments.
