
# COASTAL RESOURCES DIVISION OVERVIEW



The Coastal Resources Division of the Georgia Department of Natural Resources is entrusted by the Governor and General Assembly to manage the state's marshes, beaches, coastal waters, and marine fisheries. CRD's service area extends from the inland reach of tidal flow out three miles into the Atlantic Ocean—an area of approximately 1,000 square miles—and includes Brantley, Bryan, Chatham, Camden, Charlton, Effingham, Glynn, Liberty, Long, McIntosh, and Wayne counties. The Division is comprised primarily of two sections, Coastal Management and Marine Fisheries, with separate but complementary functions.



## **COASTAL MANAGEMENT SECTION**

Coastal & Ocean Management • Federal Consistency Shellfish & Water Quality • Compliance & Enforcement Marsh & Shore Management

The Coastal Management Section works with local, state, and federal authorities to balance economic development and population growth with protection of coastal natural, historic, and recreational resources.

Administers the Georgia Coastal Management Program

Assists local governments with public access, coastal hazard preparedness, and green growth

Funds local projects and research through grants

Monitors water quality at swimming beaches and shellfish growing areas

Issues and enforces permits for structures and activities in coastal marshlands, public waters, and along the shorelines of barrier islands



# MARINE FISHERIES SECTION

The Marine Fisheries Section provides information to manage Georgia's diverse coastal fisheries. State, interstate, and federal authorities use this information to make decisions that balance the long-term health of fish populations with the needs and desires of those who fish for commercial and recreational purposes.

Manages 18 federal grants and additional state and other fund sources



# DIVISION FUNDING

The Division's fiscal year 2025 budget is \$8.5 million, including \$3.3 million in state appropriations and \$5.2 million in federal funds.

Federal Aid in Sport Fish Restoration is a unique "user-pay, public benefit" fund sources administered by the U.S. Fish & Wildlife Service and funded by excise taxes paid by the fishing and boating industry. The State of Georgia earns these funds based a formula involving the number of licensed anglers and Georgia's landmass. Activities supported include aquatic-resources inventory surveys, fishing and boating access improvements, essential fish habitat enhancement and creation, and conservation education.

Coastal Zone Management funds are appropriated by Congress to the U.S. Department of Commerce, National Oceanic and Atmospheric Administration (NOAA). The State of Georgia qualifies for these funds by having an approved Georgia Coastal



Management Program, and providing a mandatory 50 percent match of nonfederal funds. Activities supported include technical assistance to local governments, environmental regulation, compliance, and enforcement, federal project review, and public outreach.



CRD's Support Marine Habitat has raised more than \$1 million for conservation since its launch in 2017. These funds are used to create and enhance essential fish habitat.



### **OUTREACH & EDUCATION**



The Division's largest annual event, CoastFest, will be held March 22, 2025, in Brunswick. CoastFest features live animals, touch tanks, and exhibits from nearly 100 partner organizations. Twice per year on Georgia's "Free Fishing Days," the division hosts Kids Fishing Events on Tybee Island and in Brunswick. These activities feature angling education overviews, basic fishing instructions, and bottom fishing from a pier.

CRD also hosts a variety of other events throughout the year, including brownbag lectures, rain barrel workshops, and campus visits and tours. Staff frequently visits coastal schools for programs and is available for gatherings like Rotary clubs or Savannah boat show.
