If purchasing by **mail** please enclose the following items:

- Fully completed license application(s).
- Check or money order payable to the Georgia Department of Natural Resources. **IF** paying by credit or debit card, complete all information on the enclosed credit card form.
- A photocopy of your driver's license or state-issued identification card.
- If purchasing the optional customer license, include a copy of your USCG documentation.
- If purchasing a vessel license, include a copy of your State registration or USCG documentation.
- Signed Application for Public Benefit.
