Re: Letter of Permission (LOP), Temporary Activities, Placement of a Fireworks Display, Ocean Forest Golf Club, Sea Island, Atlantic Ocean, Glynn County, Georgia, (GPS 31.20425°N/-81.32255°W)

Dear Mr. DiMeglio:

This Letter of Permission (LOP) is in response to your request, received May 5, 2023, to set up equipment for two Fireworks Shows held by the Sea Island Acquisition, LLC, within Shore Protection Act (SPA) jurisdiction at the Ocean Forest Golf Club.

To accomplish the set-up, an 8ft. x 16ft. fireworks launch trailer will be hauled onto the beach by a 4-wheel drive vehicle. The flatbed trailer will serve as the firework launch site and will be staged in an unvegetated area. Set up of the fireworks launch trailer will take place on July 4, 2023, with removal immediately after the fireworks display and again on September 29, 2023, with removal immediately after the fireworks display. For the July 4th display, in the event of rain or other unforeseen events, set up and removal will occur between June 30, 2023, and July 8, 2023. For the September 29th display, in the event of rain or other unforeseen events, set up and removal will occur between September 22, 2023, and October 13, 2023. The approved DNR vehicle access route on 36th Street will be used for the transport of the above described equipment. No dunes or dune vegetation will be disturbed during the transport or set up of any of the structures.

The Department authorizes the placement of the fireworks set up equipment as depicted in the attached description and site map and has no objection to the action. No unauthorized equipment, materials or debris may be placed, disposed of, or stored in jurisdictional areas. Any incidental damage to dunes or dune vegetation will require restoration to be coordinated through this office. This LOP is valid for the above referenced project. Any change in the use, location, dimensions, or configuration of the approved project, without prior notification and approval from this office could result in revocation of this permission and in the required

removal of the related structures.

On behalf of Sea Island Acquisition, I respectfully request a Letter of Permission for the following activities at the Ocean Forest Golf Club on Sea Island:

The 8'x16' fireworks launch trailer will be set on the existing hard-packed sand beach.

4th of July

Set up will take place 07/04/2023. In the event of rain or other unforeseen events, setup and removal will take place within the dates of 06/30/2023 to 07/08/202.

September 2023

Set up will take place 9/29/2023. In the event of rain or other unforeseen weather event, setup and removal will take place within the dates of 09/22/2023 to 10/13/2023.

The trailer will be transported by a 4 wheeled vehicle and delivered to the launch site at 36th Street, an approved beach access. (See attached exhibits). Removal will take place directly after the fireworks display. No dunes or dune vegetation will be disturbed.
